Applicants must demonstrate current artistic activity by providing an up-to-date artist CV/Resume, and they must share at least one of the following materials to support their activities:

- copies of press/exhibition materials*
- recent grant award letters/email notification*
- recent acceptance letters/email for a residency*
- website link to artist webpage, gallery postings, or other online press*

In addition, applicants will be asked to provide three short narratives, describing their project, how it was impacted by the COVID-19 crisis, and how the grant funds will be used to support their project. Applicants will also be required to identify the project expenses this grant would be used for if awarded.

Evidence submitted must be on an official company document/letterhead, stating your name, date and address (the address does not need to be the same for each document).

This evidence can be a utility bill, bank statement or bill, valid government ID (issued in 2019 or before) and or residential or studio lease. Applicants will need to provide one document from 2020, and one document from 2019.
